Adult Consent Form to Attend and Participate in School Sponsored Field Trip

All adults attending a field trip approved and sponsored by the Norwalk-Ontario-Wilton School District must read and sign this document giving verification that the person signing understands the expectations placed upon them as an adult participant. This form must be signed and returned to designated school district personnel prior to leaving for trip. If the form is not signed and returned, the adult will not be allowed to participate in the Field Trip.

As an adult participant in a field trip sponsored by the Norwalk-Ontario-Wilton School District, I understand I am a role model for the children that will also be attending the field trip. I am also expected to be a positive representative of the Norwalk-Ontario-Wilton School District. Therefore, I agree to the following:

- Follow all requests of school district personnel in charge of the trip.
- ➤ Refrain from inappropriate, vulgar or profane language.
- Maintain respectful, appropriate, and courteous interpersonal relationships with school advisors, other adults and students while on the trip.
- Refrain from the consumption or purchase of alcohol or tobacco products.
- Refrain from using, distributing or selling illegal drugs.
- Obey all local, state, and federal laws.
- Dress consistent with approved School Board Policies. Clothing banned while attending a school sponsored trip includes:
 - 1. Clothing with alcohol, tobacco or drug promotions, sexual references and innuendoes, vulgar, sexist or racist sayings or gang insignia.
 - Accessories which could be considered weapons, such as spiked wrist wear
 or ankle bands, spiked rings or chains of any size including chains attached to
 wallets.
 - 3. Underwear, bras, or boxers must not be visible, even when bending or leaning over.
 - 4. Strapless, off-the-shoulder or revealing garments/undergarments, bare midriff tops, halters or strapless tube-tops; this includes men's shirts with large sleeve openings that reveal torsos. Strapless dresses without jackets and spaghetti straps (anything less than 2 inches is considered a spaghetti strap).
 - 5. The display of cleavage, breasts or buttocks, low cut blouses, tops, sweaters, etc. with plunging necklines. Transparent and/or see through material is considered unacceptable.

- 6. Shorts, skorts, and skirts shorter than fingertip length when the adult's hand is fully extended down the side of the adult's leg.
- 7. Spandex or tightly fitting bottoms, including yoga pants. (These may be worn only if covered with another layer of clothing, such as a shirt, shorts, or skirt that adequately covers one's bottom).

Failure to follow these expectations will lead to disciplinary action by school district administration. Disciplinary action could range from a written reprimand to being suspended from participating in all future school sponsored field trips.
